presented at PBK -THSADA Hall of Honor Celebration

THSADA Regional Athletic Administrator of the Year

Presented on an annual basis to THSADA members in recognition of their dedicated service, leadership, and special contributions to their local and regional levels of interscholastic athletic administration. Award Crystal and Ring

- Current member in good standing of THSADA
- Athletic Administrator and THSADA member for at least five (5) years
- Demonstrated contributions to local, conference and/or regional interscholastic athletics
- Once a person becomes inactive in interscholastic athletics, the Awards Committee may still consider the name for the following year.

Deadline: March 7th **Voted on by Region Members, approved via virtual Board meeting.** Nominations will be held for three years. Winner sent to Region rep. THSADA Office/or Awards Chair.

Joe Bill Fox Distinguished Service Award

The Joe Bill Fox Distinguished Service Awards is a unique recognition of individuals, outside the field of Athletic Administration, who have provided service to the THSADA in truly outstanding fashion. Recipients of this award will have provided a broad spectrum of service to the THSADA and have worked to have improved athletic administrator efficiency and success. This is an open nomination to any person who has made contributions to the THSADA. Award - Crystal

Deadline: November 15. The Awards Committee will consider all nominations and determine their selection in November. THSADA awards are recommended by Awards Committee, approved at December Board Mtg. and awarded at the THSADA State Conference. Nominations will be held current for three years. Nominations sent to THSADA Office/or Awards Chair.

PBK -THSADA Athletic Director of the Year

The THSADA President is selected to receive this award at the end of his term of service. A recommendation will be made by the THSADA Awards Committee and approval will be made by the Board of Directors at the State Conference. The award will be presented in conjunction with the THSADA General Session at July Coaching School. Award Crystal and Ring

PBK -THSADA Hall of Honor Inductees

Nominated by the THSADA Membership. Awards Committee will present nominees to the Board of Directors who will approve candidates at the THSADA State Conference. Award Crystal and Ring

Criteria: In recognition of service to athletics, the THSADA and athletic administration in the State of Texas. Must have served as an athletic administrator in the State of Texas at least ten years, current member or have been a member of THSADA and have served the THSADA in some capacity.

Deadline: November 15. The Awards Committee will consider all nominations and determine their selection in November. NIAAA awards are recommended by NIAAA Committee, approved at December Board Mtg. and awarded at the THSADA State Conference. Nominations will be held current for three years. Nominations sent to THSADA Office/or Awards Chair.

Dr. Charles E. Breithaupt Citation Award

Presented to athletic administrators who have made significant contributions to the THSADA, which have impacted high school activities. Awarded at the HOH Celebration (Active THSADA members) Crystal Award (1-3 per year) Award - Crystal (March Decision)

Deadline: November 15. The Awards Committee will consider all nominations and determine their selection in November. NIAAA awards are recommended by NIAAA Committee, approved at December Board Mtg. and awarded at the THSADA State Conference. Nominations will be held current for three years. Nominations sent to THSADA Office/or Awards Chair.

THSADA Superintendent of the Year

Presented to a Texas Superintendent who has made a significant contribution to the THSADA, who has impacted high school activities. Awarded at the HOH Celebration Award- Ring (March Decision)

Outgoing Regional Director Recognition

THSADA Office will identify those Regional Directors leaving the THSADA Board of Directors after fulfilling their years of service on the Board of Directors will be recognized for their contributions as a member of this group. Awarded at the THSADA Hall of Honor Celebration Award Watch and Ring

Kelly Reeves State Award of Merit

Presented to an Athletic Director who is presently a member in good standing of both the THSADA and NIAAA; must have demonstrated long-term contributions, leadership and meritorious service to their profession of interscholastic athletics at the State and/or National level. Award - Crystal

- Current member THSADA and NIAAA
- Ten (10) years of athletic administrative service in Texas
- Time, effort, commitment to athletic administration and to the THSADA and/or NIAAA
- Demonstrated leadership in athletic administration.

Deadline: November 15. The NIAAA Committee will consider all nominations and determine their selection in November. NIAAA awards are recommended by NIAAA Committee, approved at December Board Mtg. and awarded at the THSADA State Conference. Nominations will be held for three years. Nominations sent to THSADA Office/or NIAAA Chair.

NIAAA Distinguished Service Award

Presented annually to an individual in the field of interscholastic athletic administration who has, over the years, demonstrated a service to the high school athletes of the state and/or THSADA. Award - Crystal

- Open nomination to any person who has given their time, effort and commitment to Texas High School athletics and the student participants.

Deadline: November 15. The NIAAA Committee will consider all nominations and determine their selection in November. NIAAA awards are recommended by NIAAA Committee, approved at December Board Mtg. and awarded at the THSADA State Conference. Nominations will be held for three years. Nominations sent to THSADA Office/or NIAAA Chair.

NFHS Citation

Presented to athletic administrators who have made significant contributions to the NFHS and/or other national organizations which have impacted high school activities. Award - Plaque

Among the factors which are considered:

- Individual has a long-standing and distinguished record of involvement with high school activities programs at the local and state levels.
- Individuals are recognized as among the best in their profession by their colleagues.

Deadline: November 15. The NIAAA Committee will consider all nominations and determine their selection in November. NIAAA awards are recommended by NIAAA Committee, approved at December Board Mtg. and awarded at the THSADA State Conference. Nominations will be held current for three years. Nominations sent to THSADA Office/or NIAAA Chair.

NIAAA Triple Legacy Award

Presented Annually to a NIAAA member that is a State Coordinator who has developed and implemented a new initiative for their state in the area of professional development.

- Current member THSADA and NIAAA
- Time, effort, commitment to athletic administration and to the THSADA and/or NIAAA
- Demonstrated leadership in athletic administration.

Deadline: November 15. The NIAAA Committee will consider all nominations and determine their selection in November. NIAAA awards are recommended by the NIAAA Committee, approved at December Board Mtg. and awarded at the THSADA State Conference. Nominations will be held for three years. Nominations sent to THSADA Office/or NIAAA Chair.

NIAAA Hall of Fame

The NIAAA Hall of Fame is organized as a means of recognizing interscholastic athletic administrators, promoting the vocation of athletic administration and preserving the heritage of the profession. This national recognition is the highest honor an athletic administrator can have bestowed upon them from the NIAAA for his/her contributions and accomplishments.

Nominations/Criteria

Nominations for the NIAAA Hall of Fame may be made by individuals who are current NIAAA members or State Athletic Administrator Associations. A state athletic administrator association may nominate only one person in each category annually. Posthumous nominations will be accepted.

Deadline: November 15 The NIAAA Committee will consider all nominations and determine their selection in November. NIAAA awards are recommended by the NIAAA Committee, approved at December Board Mtg. and awarded at the THSADA State Conference. Nominations will be held for three years. Nominations sent to THSADA Office/or NIAAA Chair.

Frank Kovaleski Professional Development Award

Guidelines for the Awards Committee:

Award - Crystal

- The nominee selected should be a member in good standing of the NIAAA and have earned at least the CAA designation.
- Each section (section 6) shall be allowed one nominee per year.
- A nominee's contributions to professional development should be detailed on the next page of this form.
- This nomination form must be type written and in the hands of your section Board representative at least one week prior to your spring section meeting (April)

Deadline: November 15 The NIAAA Committee will consider all nominations and determine their selection in November. NIAAA awards are recommended by the NIAAA Committee, approved at December Board Mtg. and awarded at the THSADA State Conference. Nominations will be held for three years. Nominations sent to THSADA Office/or NIAAA Chair.

All THSADA/NIAAA award nominees that are approved by the THSADA Board of Directors, must be active/retired members of the THSADA. All THSADA/NIAAA nominations are kept active for three years.
